## **MCA Corporate Trophy 2022-2023**

- 1) The Tournament shall be MCA CORPORATE TROPHY 2022-2023
- 2) The Tournament shall run in six or seven Divisions depending on number of participation teams (A, B, C, D, E, F & G)
- 3) Format for all division matches will be decided depending on number of teams.
- 4) Entry Fees: Rs 5000/- plus 18% GST (Only Company Cheque. Cash not accepted)
- 5) Offices: Private/Public Business Houses/State & Central Government Offices/Professional Firms/Any other Company who recruit Cricketers in their Company. Office Address should be in MCA
- 6) Permanent/Contract/Scholarship Players should have Permanent MCA Card and Outstation Players should have Temporary MCA Card.
- 7) A, B Division teams can include any number of players who have played First Class Cricket under the auspices of BCCI. C & D Division Teams can include a maximum of 3 players who have played First Class Cricket under the auspices of BCCI. E, F & G Division Teams can include a such players who have played First Class Cricket 5 years before the commencement of season 2022-2023 under the auspices of BCCI.
- 8) Penalty of slow over rate shall be as per MCA Model Rule
- 9) All the players should carry their Office ID Card as well as MCA Registration ID during the match.
- 10) Ground Allotment for all Divisions shall be done by MCA.
- 11) Umpires and Scorers for all Divisions will be appointed by MCA.
- 12) Balls for the Tournament for all Divisions will be provided by MCA.
- 13) All Division matches shall be played as per the schedule approved by MCA Kanga & Tournament committee.
- 14) Competing Clubs shall not mutually prepone or postpone their matches for any reason without the prior approval from MCA Kanga & Tournament committee.
- 15) The Umpires shall be the sole judge for fitness of the ground, whether condition and light. Umpires decision will be final and binding in any point arising out of the interpretation of the Law of the game.
- 16) The Ground charges will be paid by both the teams and the same will be reimbursed on company account given in the form. Umpire & Scorer charges will be paid by MCA.

17) Any Office Team giving Walk Over in any of the League or Knockout Matches without communicating to MCA in Writing shall have to pay their share of expenses towards ground, umpire and scorer charges of that particular match. Such Office team shall not be given entry in the tournament in the Following two years after the current Tournament season.

18) A protest against the opponent shall be jointly signed by the authorized signatory & The Secretary of the Office which should be submitted to MCA along with the protest fee of Rs 3000/- including GST in cash with 48 hours of the completion of the match. A copy of the protest shall also be served simultaneously to the alleged defaulting team by the protesting team. Protest shall be investigated by Kanga & Tournament Committee and relevant MCA Committees and their decision shall be final and binding on all the parties concerned. The Captain and the Secretary of the Club or the Authorized Signatory of the parent company of the respective club shall only be permitted to represent the club during the enquiry meetings with the Kanga & Tournament Sub-Committee and relevant MCA Committees. No other persons except these representatives shall be allowed to attend the enquiry meetings. If the protest is upheld, the protest fee will be refunded. If not, the protest fee will be forfeited. No further appeals / submissions will be entertained, by M.C.A. After Investigation, if the Club is found to have breached any of the rules of the tournament, such Club shall not be allowed to participate further in the Tournament during the season. No protest shall be entertained against the decision of any Umpire on a point of Fact.

19) No 30 yards Marking for the tournament.

20) MCA has the right to change or amend any rule for the Tournament. MCA's decision will be final and binding.

21) Certified photocopy of the ID Cards issued by the Employer and MCA Reg. Card of all listed players must be attached along with this form, without which, the Entry Form will not be accepted

**22) Last date of acceptance of Entry Forms is 15<sup>th</sup> December 2022 (Timings 11:00 a.m. to 7:00 p.m. (Monday to Friday) at the Mumbai Cricket Association Office, Churchgate**

**23) A copy of this 'List of Players' ACKNOWLEDGED by Mumbai Cricket Association shall only be exchanged with the opponent Club after marking the players for the match, at the time of toss of every single match.**

24) All matches will be played as per MCA Model Rules & Playing Condition. No match will be re-scheduled.

25) **Permanent Employee** on payroll of the employer on or before 15 September 2022 and drawing pay scale fixed for the respective posts held by them in the jurisdiction of MCA are eligible to play for their employer. **Outstation Player** on payroll of the employer on or before 15 September 2022 and drawing pay scale fixed for the respective posts held by them in the branches / units existing outside the jurisdiction of MCA are eligible to play for

their employer in the Tournament. **Contract Players** with the applicant organization rising within outside the jurisdiction of MCA are eligible to represent their organisation provided they meet the conditions specified for respective Divisions. These players must be on fixed term of employment with the employer on or before **15 December 2022**. **Sports Scholarship Players** from age of 16 to 25 years as on or before **15 December 2022** and residing within the jurisdiction of MCA are eligible to represent their organisation provided they meet the conditions specified for respective Divisions. The Office Clubs shall submit bonafide certificates of current academic year of Sports Scholarship players from their respective Govt. recognized educational institutions (School & College) in the Jurisdiction of MCA. An employee who is on payroll of more than one organisation cannot participate in the Tournament. The Players listed in the entry form of a particular Office Club are eligible to represent only for that particular Office Club in case of multiple entries of an organisation.

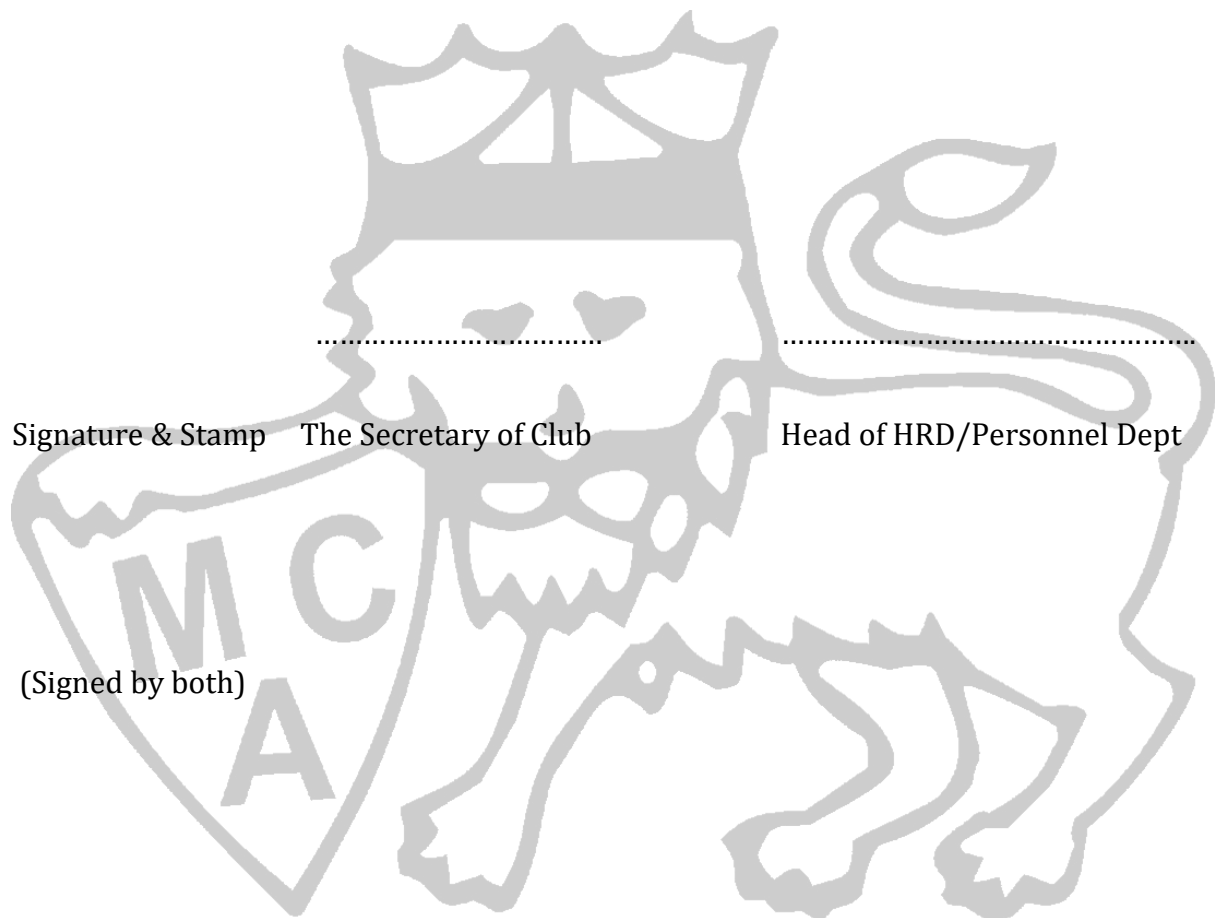


### **Terms & Conditions for the Players**

Certified photocopy of the ID Cards issued by the Employer and MCA Reg. Card of all listed players must be attached along with this form, without which, the Entry Form will not be accepted.

Submit certified copy of the original letter of appointment of those permanent employees of the Company who are exempted under P.F. Act.

- a) A and B Division – Maximum 30 players to be submitted in the squad list. In playing XI maximum 6 outstation players are allowed and 5 contact/scholarship players are allowed. If team does not have any outstation players then they can have 9 contract/ scholarship players in playing XI.
  - b) C to F Division - Maximum 30 players to be submitted in the squad list. In playing XI maximum 2 outstation players are allowed and 5 contact/scholarship players are allowed. If team does not have any outstation players then they can have 7 contract/ scholarship players in playing XI.
  - c) Qualifier Division - Maximum 30 players to be submitted in the squad list. All players should be permanent employees residing in the Jurisdiction of Mumbai Cricket Association.
  - d) A & B Division matches will be played with White Ball & Colour Clothing.  
C to F/Qualifier Division matches will be played with Red ball and White Clothing.
  - e) Also there will be no limit (Outstation/Contract/Scholarship) in submission of final list of 30 Players.
  - f) U-19 Players is not mandatory in any division
  - g) Scholarship players age should be 16 to 25 years. No Age limit for Contract players.
  - h) Junior College Players can Play all MCA Affiliated Office Tournaments.
  - i) Teams having Three or more players who have represented Mumbai team in Ranji/ U-25/ U-23 BCCI tournament in the last 5 years (after season 2017-2018) and should be given entry directly upto C Division in Times Shield/MCA Corporate Trophy.
  - j) Times Shield Committee should invite revised list of players from all the participating teams for the season 2022-2023 based on above revised rules and combination of players.
  - k) For any protest in Times Shield, the organizer will take decision on the protest. And if the decision of Times Shield organizer is not accepted by any team then the team can lodge an appeal before Mumbai Cricket

Association with Rs 3000/- including tax within 48 hours of Times Shield decision.

- l) All participating teams should ensure that their players are registered with newly developed Online MCA Registration portal. Old Green or White Paper registration is not valid from season 2022-2023 onwards. <https://mcaregistration.com/#/Mumbai%20Cricket%20Association/layer/registrations>.

- m) Revised Ground Charges from season 2022-2023 onwards

<b>For Office tournament</b>	<b>New Charges (T-20 matches)</b>
a. Grounds with tents (minimum 30 chairs, 4 tables, Proper scoreboard)	Rs 1225/- per team
b. Ground with semi permanent structure (With pavilion, electricity and drinking water facility)	Rs 1525/- per team
c. Gymkhanas like Hindu, Islam, Parsee, Police, etc (With pavilion and catering facility)	Rs 1850/- per team + GST
d. All finals at above gymkhanas	Rs 2150/- per team + GST

Note that if Single T-20 match is played on a ground then teams have to pay double ground charges which will be reimbursed by MCA in Company's account
