Kindly send your requirement of tickets on your club's letterhead duly signed by the authorised signatory of the Club on or before **Monday**, **18**<sup>th</sup> **December 2023** before **6.00 p.m.** in the office of the Mumbai Cricket Association along with the payment.

A club can apply for maximum 20 tickets of Sachin Tendulkar Stand / Dilip Vengsarkar Stand and 2 tickets of Sunil Gavaskar Stand.

The date of issue of ticket distribution will be announced on our website (www.mumbaicricket.com).

Payments will be accepted during office hours as follows:

11.30 a.m. to 2.00 p.m.	}	on all working days
3.00 p.m. to 6.00 p.m.	}	

Tickets will be delivered only to the Authorised Signatory or a person duly authorised in writing by the Authorised Signatory of the Club on producing the letter of allotment.

It shall be the responsibility of the Member Clubs to obtain necessary license, authorization or permission for Sale of tickets and to pay the necessary fees for sale of tickets and incur all other expenses incidental thereto.

Tickets must be shown as and when demanded by the Supervisors/Ushers.

The Association reserves its rights to remove from the Stadium any person who occupies the seats allotted to any Member Club for any objectionable or indecent behavior or to maintain general peace and order.

The Association reserves to itself the right to retake possession of seats at any time, even after the acceptance of money on breach of any conditions mentioned above.

Member Clubs will indemnify the Association and all persons action on their behalf from all claims and demands whatsoever, arising directly or indirectly out of the breach or non-observance of the terms of allotment.

The Association shall not be responsible in any manner, if the match is not played for any reason whatsoever.

Full refund will be granted in case the match is cancelled or abandoned without a ball being bowled.

Please ensure that your Club obtains License for the sale of tickets from the Commissioner of Police. For any confiscation of tickets or for any penalty imposed by the authorities on the Clubs for such failure, the sole responsibility shall be of the concerned Clubs.

The tickets are issued strictly subject to conditions printed on the ticket and/or any other conditions, which may be imposed by the police authorities for regulating entry into the Stadium.
