## MCA ELECTIONS FOR THE POST OF VICE PRESIDENT

### REPORT OF SCRUTINY PROCEEDINGS

#### SCRUTINY of Nomination Forms Dated 02/12/2022 from 11:00 am

- 1) Scrutiny of 4 nomination forms received from two candidates started at around 11:40 am, on 02/12/2022 after arrival of both the candidates at Conference Hall of MCA, Wankhede Stadium, Churchgate, Mumbai.
- 2) Scrutiny of Nomination Form was done by Shri. J.S. Saharia (Electoral Officer) in the presence of Shri Avinash Sanas (Authorized Officer), Shri Kinjal Patel (Authorised Officer), Shri Naresh Patil of MCA and both the candidates Shri Sanjay Naik and Shri Iqbal Shaikh.
- 3) Shri Sanjay Naik gave Objection in writing against the candidature of Shri. Iqbal Shaikh, which was signed both by Adv. Abhishek Bhat and Sanjay Naik. Shri Sanjay Naik alleged that Shri Shaikh has no locus standi to contest because his proposer and seconder have withdrawn their consent by the letters dated 30/11/22 (6:35 pm) and 01/11/22 (12:10 pm). Shri Sanjay Naik requested to allow his advocate Shri Abhishek Bhat to represent his case.
- 4) Shri Shaikh requested for the copy of objection, which was agreed to by the E.O. Shri Shaikh also drew attention of E.O. to his emails dated 30/11/22 and 02/12/22, alleging undue influence on his proposer and seconder. The copies of above 2 emails were given to Shri Sanjay Naik on his request
- 5) E.O. agreed to the request of Shri Sanjay Naik of allowing his Adv. Bhat, to argue his case in the interest of justice Adv. Bhat reiterated that Shri Shaikh has no locus standi to contest the election since his proposer and seconder have withdrawn their consent in writing. He drew attention to the Rules 32 and 33 of the Constitution of MCA and rules 3, 5 and 22 of the Rules of Election.
- 6) After the arguments of Adv. Bhat, Shri Shaikh requested time till tomorrow 11:00 am for filing his reply after consulting his lawyer and representing his case through the lawyer, if felt necessary.
- 7) After hearing Shri Sanjay Naik, Shri Shaikh and Adv Bhat; E.O. adjourned the hearing and scrutiny till 11:00 am on 3<sup>rd</sup> December 2022 at the same venue.
